In the event of loss or damage to said parcel(s), Naples Grande Beach Resort will act as agent on behalf of the customer for the filing and processing of claims. It is hereby expressly agreed that Naples Grande Beach Resort shall have no liability if any claim is denied or paid only in part by the Carrier.
2. Customer shall not Naples Grande Beach Resort liable for failure to make timely delivery on delivery date specified. Any statement by Naples Grande Beach Resort or its representatives as to probable date of delivery by carrier is a statement of opinion only and shall not be warranted in any manner. Naples Grande Beach Resort shall not be liable for any delays in shipment or deliveries by the carrier.
3. I certify that the item(s) presented for shipment does not contain any unauthorized and/or undisclosed explosives, incendiaries, alcohol or otherwise hazardous materials.
4. I hereby agree to indemnify, defend and hold Naples Grande Beach Resort harmless from all claims, demands, expenses including attorneys' and consultants' fees and costs, causes of action, fines, enforcement procedures, and suits of any kind or nature that it may incur as a result of my failure to disclose any item(s) presented for shipping.
5. Claims not made in writing within 10 days for air shipments or 30 days for ground shipments are waived.
6. Carrier liability for loss or damage is limited to US\$100.00 on shipments with no declared value. The shipping carrier shall not be liable for an amount in excess of the declared value of an insured domestic package or international shipment or pallet.
